**(Expression of Interest (EoI) for Publication of University Books and Journals)**

On behalf of the Vice-Chancellor, Mahatma Gandhi Central University (MGCU), Expression of Interest (EoI) is invited from publishers of academic books and / or journals to publish the books and journals of the University. The publisher will be responsible for the publication, distribution, marketing and selling of these books and journals.

Publishers engaged in the publication of academic books and /or journals for a minimum of ten years and with an annual turnover of more than Rs. 2 Crores per annum in the last three years can apply, offering their terms and conditions. The publisher has to ensure high quality publication in terms of quality of paper, printing, binding, book jacket, design, proof reading and overall book layout as per MGCU norms. The publication of such books shall be in the name of the University and the copyright shall be retained by '**Mahatma Gandhi Central University**'. The publisher shall be the collaborator 'Publishing House'. The publisher has to also ensure publication adhering to the deadlines specified by the University.

The EoI must be submitted in two sealed envelopes, containing a brief proposal clearly indicating the profile of the publisher, its organisational structure along with the availability of in-house facilities for undertaking the task, its experience in publishing academic books, details of the projects undertaken in past ten years, qualifications and experience of the team that will be undertaking the task, and other details elaborating on its capacity to undertake the work (**Annexure I**). The envelope No. 1 will be superscribed as '**Technical Bid**'. The other envelope No. 2 will be superscribed as '**Financial Bid**' and shall contain the financial terms and conditions for publishing these monographs / books / journals / publications as well as the percentage of royalty offered to the University (**Annexure II**).

- a. The EoI in the prescribed format, complete in all respects, duly sealed and signed by authorized signatory, must be submitted on/before 4.00 PM on 15<sup>th</sup> March, 2017.
- b. The EoI shall be submitted in two sealed envelopes as specified earlier.
- c. All envelopes shall be addressed to 'The OSD (Administration) / The Registrar, Mahatma Gandhi Central University'.
- d. The last date to submit the EoI in all respects, duly sealed and signed by the authorized signatory to the office of the 'The OSD (Administration) / The Registrar, Mahatma Gandhi Central University, "TempCamp" Zila School Campus, Motihari – 845 401, East Champaran' on/before 15<sup>th</sup> March 2017 at 4.00 P.M. through Regd. / Speed Post / Courier only.
- e. The University will not be responsible for postal or any other delays in receipt of EoIs.
- f. EoIs received after due date will not be considered.
- g. No overwriting, corrections or cutting is permitted in the EoI.
- h. Unsealed envelopes or unsigned EoIs will not be considered.
- i. The University reserves the right to reject any or all EoIs at any stage as well as the right to add/delete/modify any one or more of the terms and conditions with reasons to be recorded in writing.
- j. No TA/DA or out of pocket expenses will be admissible to attend any meeting, submission of offer or during completion of job.
