B.Sc. (Honours) Botany	Passed 10+2 or equivalent examination with Biology/Bio-technology/Agriculture, Chemistry and Physics as subjects at 10+2 level securing a minimum of 60% marks in aggregate from a recognised Board.
B.Sc. (Honours) Zoology	Passed 10+2 or equivalent examination with Biology/Bio-technology/Agriculture, Chemistry and Physics as subjects at 10+2 level securing a minimum of 60% marks in aggregate from a recognised Board.
B.Sc. (Honours) Physics	Passed 10+2 or equivalent examination with Physics, Chemistry and Mathematics as subjects at 10+2 Level securing a minimum of 60% marks in aggregate from a recognised Board.
B.Sc. (Honours) Chemistry	Passed 10+2 or equivalent examination with Physics and Chemistry as subjects at 10+2 level securing a minimum of 60% marks in aggregate from a recognised Board.
B.Sc. (Honours) Mathematics	Passed 10+2 or equivalent examination with Physics, Chemistry and Mathematics as subjects at 10+2 level securing a minimum of 60% marks in aggregate from a recognised Board.
B.Com. (Honours)	Passed 10+2 or equivalent examination with Accounting/ Mathematics/Business Mathematics as one of the subjects at 10+2 Level securing a minimum of 60% marks in aggregate from a recognised Board.
B.Tech. in Computer Science and Engineering	Passed 10+2 or equivalent examination with Physics and Mathematics as compulsory subjects alongwith one of the subject from among Chemistry / Biotechnology / Biology / Technical Vocational subject, securing a minimum of 60% marks in the aggregate from a recognised Board.
B.A. (Honours) in Economics/Political Science/ Hindi/English/Sociology	Passed 10+2 or equivalent examination with a minimum of 60% marks in aggregate from a recognised Board.
Master of Business Administration (MBA)	A minimum of 60% marks or an equivalent grade in a UG degree recognised by any statutory body approved by Government of India.
Master of Social Work (MSW)	A minimum of 60% marks or an equivalent grade in a UG degree recognised by any statutory body approved by Government of India.
