Term & Conditions: -

1. Eligibility Criteria of Bidders:

- a) Bidder should be Authorized Education Partner (AEP) of Microsoft.
- b) The bidder must attach an Authorization Letter from the OEM (Manufacturer) specific to this Tender enquiry and addressed to OSD (Administration), Mahatma Gandhi Central University, "Camp Office" Near O.P. Thana, Raghunathpur, Areraj Road, Motihari 845 401, failing which tender will be rejected.
- c) Bidders are requested to quote their offer with one year, which may be extended to additional two years in future as per requirement of the University.
- d) The average turnover of the bidder should not be less than 30 lakhs for the preceding 3 years.
- e) The tender fee of Rs. 1000/- in shape of Demand Draft in **favour of OSD** (Administration), Mahatma Gandhi Central University Payable at Motihari should be submitted along with tender documents.

2. Submission of Bid:

- a) The bidder shall go through the entire documents and must comply with all the term and conditions.
- b) The bid in sealed envelope should bear the inscription as "Tender for Software's NIT no: **NIT NO. 01/2018/MGCUB**".
- c) The bid must be submitted in one sealed envelope with the following document.
 - 1. A letter of authority duly signed by an authorized signatory.
 - 2. Technical Documentation [Product brochures, leaflets, manuals etc.
 - 3. Demand draft of Rs 50,000.00/- (Rupees Fifty Thousands only) as EMD needs to be attached in favour of OSD (Administration), Mahatma Gandhi Central University Payable at Motihari.
 - 4. Guarantee/Warranty details must be mentioned.
 - 5. All pages of the bid documents must be signed and stamped by the authorized signatory of the bidder.
 - 6. The rates should be quoted in Indian rupees.
 - 7. GST if any must be mentioned clearly in the bid. Rates should be quoted separately mentioning the basic price, duties, taxes, etc. if any.
 - 8. The bidder must enclose copies of PAN no., GST, Registration no.etc, along with the bid. If the said documents are found false, the Mahatma Gandhi Central University will take necessary action against the firm/vendor as per the rules.
- d) The sealed tenders should be sent by the registered post/courier/speed post or dropped in the tender box kept in the OSD (Administration), Mahatma Gandhi Central University, "Camp Office" Near O.P. Thana, Raghunathpur, Areraj Road, Motihari 845 401 on or before 26th November 2018 (Monday) by 5:00 PM. Tenders sent by other means will not be accepted.

Bids received after the due date and time will not be entertained at any cost.

3. Opening of Bid:

The Technical Bid shall be opened on 27th November 2018 (Tuesday) at 3:00 PM at Mahatma Gandhi Central University, Camp Office, Near O.P. Thana, Raghunathpur, Areraj Road, Motihari – 845 401. The bidders or their authorized representative may also be present during the opening of the Bid, if they desire so, at their own expenses.

4. Validity of bids:

Bids should be valid for a minimum period of 90 days after the opening of the date of the bid.

5. Earnest Money Deposit:

a) Bid for this tender must be accompanied with an Earnest Money Deposit of Rs. 50000/-(Rupees Fifty Thousand only) in the form of Demand Draft in favour of 'OSD
(Administration), Mahatma Gandhi Central University' payable at Motihari.
Quotations received without Earnest Money Deposit will be rejected.

- **b)** Earnest Money shall be forfeited and the bid is liable to be rejected, if the bidder withdraws or amends or impairs or derogates from the tender in any form within the period of validity of the tender.
- c) The earnest money shall be liable to be forfeited in case of non-supply of ordered equipment's.
- **d)** No interest will be payable by Mahatma Gandhi Central University, Motihari Bihar, on the Earnest Money Deposit returned to the unsuccessful bidder.

6. Rejection of Bids

- a) The University reserves the right to accept or reject any bid or cancel the tender proceedings without assigning any reason whatsoever.
- b) If a bidder gives wrong information in their bids(s), **Mahatma Gandhi Central University** reserves the right to reject such bid(s) at any stage and to forfeit the Earnest Money Deposit and cancel the contract, if awarded.
- c) Incomplete quotations are liable to be rejected.
- d) **Mahatma Gandhi Central University** will not pay any costs incurred towards preparation and submission of the bid or any other expenditure in this regard.
- e) Unsigned tenders, unattested corrections and over writing by bidders are also liable for rejection.

7. Payment

- a) Payment for this procurement shall be made with all taxes and levies except custom duty and excise duty as the **Mahatma Gandhi Central University** is exempted from Custom Duty & Excise Duty.
- b) The 100% payment for this procurement shall be released only after the satisfactory completion/installation of equipment within the prescribed period of time mentioned in the supply order. The payment will be made after certification of operation by the users incharge.
- c) Performance Security @ 5% of total cost for six months.

8. Clarifications

In case the bidder requires any clarification regarding the tender document, they are advised to submit their question in writing to OSD (Administration), Mahatma Gandhi Central University, "Camp Office" Near O.P. Thana, Raghunathpur, Areraj Road, Motihari – 845 401

9. Inspection

Mahatma Gandhi Central University shall have the right to inspect or to test the items after delivery to confirm their conformity to the required specifications. The supplier shall provide all reasonable facilities and assistance to the inspector at no charge to Mahatma Gandhi Central University, New Delhi. In case any inspection of tested service fails to conform to the specifications, Mahatma Gandhi Central University may reject them and the supplier shall

make all alterations necessary to meet specifications required free of cost to **Mahatma Gandhi** Central University.

10. Delivery of the product

- a) All the Software need to be delivered at **OSD** (Administration), Mahatma Gandhi Central University, "Camp Office" Near O.P. Thana, Raghunathpur, Areraj Road, Motihari 845 401 by the supplier at its own cost.
- b) The equipment shall be supplied within a period of 30 days from the date of supply order failing which EMD shall be forfeited.

11. Installation & Warranty

- a) Installation and integration of all supplied software shall be done by the bidder/supplier.
- b) The bidder shall conduct acceptance test of the supplied equipment at the installation site and demonstrate the functionalities as per specifications.
- c) The Guarantee/warranty will start from the date of installation of the equipment.
- d) The supplied equipment hardware must have one year on-site comprehensive warranty.
- e) If unresolved issues are pending, warranty duration would be extended till satisfactory resolution of issues without any extra cost to Mahatma Gandhi Central University.
- f) The bidder will have to arrange all the testing equipment & tools required for installation, testing & maintenance, etc., at his/her own cost.
- g) Mahatma Gandhi Central University will have the right to reject the components/equipment's supplied at any point of installation/inspection, if it does not comply with the specifications.
