1. This is in continuation to **Advertisement No. 005/2019 dated 31st May 2019** issued by the University vide which **Offline Applications** were invited for various **Non-Teaching Positions** to be filled **purely on contract basis** initially for a period of **six months**.

2. **DATE, TIME & VENUE OF WRITTEN EXAMINATION:**

3. **CANDIDATES CALLED FOR WRITTEN EXAMINATION:**

- i. The complete list of all applicants giving their critical information and decision of the Committee with regard to their eligibility along with the reasons for their non-eligibility are appended below:
 - a. Upper Division Clerk (**ANNEXURE - 1**) (**Page No. 6 to 14**); and
 - b. Lower Division Clerk (**ANNEXURE - 2**) (**Page No. 15 to 21**)

Although all efforts have been made to ensure accuracy in preparing the lists as mentioned at Para 3(i) above, possibility of inadvertent error or typographical mistake(s)/omission cannot be ruled out. The University will incorporate the genuine and justified requests, if any, on receipt from applicants.

- ii. All applicants who have **submitted/dispatched** their duly filled-in application form for the aforesaid Non-Teaching Positions, along with supporting documents & requisite fee (wherever applicable), on or before **17th June 2019 (Monday)** and fulfil the minimum eligibility as per the advertisement, have been called for Written Examination, as per scheduled given on pre-page.
- iii. The eligibility of the applicants has been determined as on the last date of receipt of applications as per the advertisement.
- iv. **Merely securing good marks in the Written Examination Test will not make anyone entitled to become eligible for Skill Test/Appointment.**

4. **IMPORTANT NOTE:**

- i. The call letters to all applicants is being sent separately through **Email only**, therefore, the candidates are advised to check their Email ID as provided by them in their application form.
- ii. In case a candidate who have applied for any of the aforesaid Non-Teaching Post and did not receive call letter by **24th September 2019 (Tuesday)** are advised to bring the same to the notice of the University by writing an email to **osdadmin@mgcub.ac.in** positively along with documentary evidence (i.e., copy of application form submitted and demand draft, if applicable). **Request received after 24th September 2019 will not be entertained.**

5. **MODE/CRITERIA OF FINAL SELECTION:**

Final Selection will be done on the basis of performance in the Written Examination and further qualifying the Skill Test.

Note:

In case of tie in Written Test marks, merit will be prepared in following order:

- a) Senior in age
- b) Marks secured in qualifying degree examination.

6. **PATTERN OF THE WRITTEN EXAMINATION:**

A. Upper Division Clerk (UDC):

- i. The Written Examination shall be of Objective Type comprising **50 Multiple Choice Questions (MCQs)** with the following composition, **lasting for a duration of 60 Minutes:**
 - a. English;
 - b. Maths;
 - c. General Knowledge and General Awareness;
 - d. General Intelligence & Reasoning; and
 - e. Domain Knowledge and/or Knowledge of Rules of Government of India, Office Procedures & University Act
- ii. Language of the Written Examination will be English only. Each correct answer will carry one mark and there will be **no negative marking** for wrong answer in the Written Examination.

B. Lower Division Clerk (LDC):

- i. The Written Examination shall be of Objective Type comprising **50 Multiple Choice Questions (MCQs)** with the following composition, **lasting for a duration of 60 Minutes:**
 - a. English;
 - b. Maths;
 - c. General Knowledge and General Awareness;
 - d. General Intelligence & Reasoning; and
- ii. Language of the Written Examination will be English only. Each correct answer will carry one mark and there will be **no negative marking** for wrong answer in the Written Examination.

7. **SYLLABUS OF THE WRITTEN EXAMINATION FOR THE POST OF UPPER DIVISION CLERK (A TO E) AND LOWER DIVISION CLERK (A TO D):**

A. English:

In addition to the testing of candidate's understanding of the English Language, its Vocabulary, Grammar, Comprehension, Letter Writing, Precis, Sentence Structure, Synonyms, Antonyms and its correct usage etc. would also be tested.

B. Maths:

This paper will include questions on problems relating to Number Systems, Computation of Whole Numbers, Decimals and Fractions and relationship between Numbers, Fundamental arithmetical operations, Percentages, Ratio and Proportion, Averages, Interest, Profit and Loss, Discount, Mensuration, Time and Distance, Ratio and Time, Time and Work, etc.

C. General Knowledge and General Awareness:

Questions in this component will be aimed at testing the candidate's general awareness of the environment around him. Questions will also be designed to test knowledge of current events and of such matters of everyday observations and experience in their scientific aspect as may be expected of any educated person. The test will also include questions relating to India and Bihar especially pertaining to sports, History, Culture, Geography, Economic Scene, General Polity, Indian Constitution and Scientific Research etc. These Questions will be such that they do not require a special study of any discipline.

D. General Intelligence & Reasoning:

Analytical aptitude and ability to observe and distinguish patterns will be tested through questions principally of non-verbal type. This component may include questions on analogies, similarities and differences, spatial visualization, spatial orientation, discrimination, observation, relationship concepts, arithmetical reasoning and figural classification, arithmetic number series, non-verbal series, coding and decoding, etc.

E. Domain Knowledge and/or Questions related to Statutes/Ordinances/Regulations of University and/or University Act etc.:

(only for the post of upper division clerk):

Questions in this component will be aimed at testing the candidate's Domain Knowledge and/or Awareness of Rules of Government of India, Central Secretariat Manual of Office Procedures & University Act. The test will include questions relating to:

- i LTC Rules;
- ii Joining Time;
- iii TA Rules;
- iv 7th Pay Commission;
- v CCS (Leave Rules);
- vi Right to Information Act 2005; and
- vii University Act, Statutes and Ordinances etc.

8. The **Skill Test** is **compulsory**. However, Skill Test will only be of qualifying nature. **Final Selection/Assessment will not (NOT) be done on the basis of marks of such test.** The Date, Time and Venue of Skill Test shall be notified separately. Therefore, the candidates are advised to check the University Website regularly.
9. The appointment of the candidate on the basis of marks in Written Examination shall be provisional and subject to qualifying in skill test; verification of her/his Character & Antecedents; and if applicable her/his Caste/Tribe/Community Certificate from the respective authorities through proper channel. If the verification reveals anything adverse about her/his character and antecedents and/or that the claim to belong to the Scheduled Caste/Scheduled Tribe/Other Backward Class (Non-Creamy Layer), as the case may be, is false, her/his services will be terminated forthwith without assigning any reasons thereof and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates.
10. The decision of the University in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, conduct of examination(s), allotment of examination centres and preparation of merit list will be final and binding on the candidates and no enquiry/correspondence will be entertained in this regard.
11. Written Examination/Personal Interaction/Skill Test for rest of the Non-Teaching Positions advertised vide Advertisement No. 005/2019 dated 31st May 2019 is **likely to held shortly**. Therefore, all the concerned applicants are advised to check the University Website regularly for updates.

12. **CHANGE OF DATE OF WRITTEN EXAMINATION:**

Any request for change of date of Written Examination/Seat in the Examination Hall will not be entertained.

13. **TA/DA:**

No TA/DA will be admissible for attending the Written Examination. Travelling and other expenses must be borne by the candidates themselves.

IMPORTANT NOTE:

1. The candidates applying for any Non-Teaching Positions should ensure that they fulfil all the eligibility conditions for admission to the Written Examination. Their admission at all the stages of Written Examination will be purely provisional, subject to their satisfying the prescribed eligibility conditions. If, on verification, at any time before or after the Written Examination and Skill Test, it is found that they do not fulfil any of the eligibility conditions, their candidature for the examination will be cancelled by the University.
2. The candidates must carry their Admit Card along with at least one latest photo bearing identification proof such as Driving Licence / Voter Card / Aadhaar Card / Identity Card issued by University / College, Income Tax Pan Card in original to the Examination Centre, failing which they will not be allowed to appear for the same.
3. Any attempt to influence the authorities by way of recommendations will ab-initio disqualify the candidate.
