Admission shall be strictly based on merit list derived from the composite score taken together on the basis of 20% of percentage of marks of Class-10th, 30% of percentage of marks of Class-12th, 40% of percentage of marks of Graduation, 5% of Extra Co-Curricular Activities and 5% of Interaction/Skill Test/Group Discussion in accordance to the provisions made in the University Prospectus.
- 3. Candidates are advised to report on the scheduled date and time to the venue along with required documents.
- 4. All candidates are advised to check their eligibility for respective programmes as notified by MGCUB admission prospectus 2020-21 before appearing for counseling / admission.

- 5. Wait-listed candidates shall only be considered for admission if seats remain vacant in given program of studies.
- 6. Candidates who fail to report for admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for admission.
- 7. In case of tie, senior candidate on the basis of Date of Birth shall be given preference. In case of any dispute, the decision of the University administration shall be final.
- 8. The admission of candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
- 9. The candidates shall be required to pay the fees in the form of Challan/Demand Draft drawn in favour of "Mahatma Gandhi Central University" payable at Motihari at the time of admission.
- 10. Admission shall be granted only on the payment of fees on the specified date.
