Instructions for candidates

- 1. At the time of counseling/admission candidates must use face covers/masks within university premises.
- 2. Formats of selected documents required at the time of admission are annexed with this notice.
- 3. From the pool of candidates who **report within the due time on the day of counseling**, admission would be done in order of merit for all the categories, subject to reservation rules and an overall intake capacity of **33 seats** in M. Tech CSE.
- Fee payable at the time of admission into the M. Tech. CSE programme is Rs. 15,718/-. The fee would be deposited on the day of admission after document verification through challan. Fee structure and other details are provided in the Admission notification (Post Graduate Programmes), Academic Session: 2022-2023 available at https://mgcub.ac.in/pdf/2022092917071693dcf2ec52.pdf.
- 5. If at any stage it is found that the applicant has furnished wrong information in the online application form then the admission would be canceled.
- 6. Admission into M.Tech programme would be confirmed only after document verification and submission of proof of fee deposit through challan.

Admission of candidates seeking admission after a gap of three or more academic years of passing Intermediate/10+2 examination from any University/educational institution/Board, shall be subject to the clearance by the **Admission Review Committee** consisting of the Dean, Students' Welfare (DSW), the Dean of the School concerned, the Head of the Department concerned and the Proctor.
