- 2. Admission shall be strictly based on CUET (PG) Score-2023.
- Candidates are advised to report on the scheduled date and time to the venue along with required documents
- All candidates are advised to check their eligibility for respective programme as notified by NTA Information Bulletin for the admission in PG programme through CUET (PG) – 2023.
- 5. Wait-listed candidates shall only be considered for admission if seats remain vacant in given program of studies.
