- 1. Candidates are advised to follow the COVID guidelines at the time of counselling.
- 2. Admission shall be strictly based on CUET (PG) Score-2023.
- 3. Candidates are advised to report on the scheduled date and time to the venue along with required documents.
- 4. All candidates are advised to check their eligibility for respective programme as notified by NTA Information Bulletin for the admission in PG programme through CUET (PG) – 2023 (https://cdnbbsr.s3waas.gov.in/s3d1a21da7bca4abff8b0b61b87597de73/uploads/2023/03/2023032020.pdf) before appearing for counseling / admission.
- 5. Wait-listed candidates shall only be considered for admission if seats remain vacant in given program of studies.
- 6. Candidates who fail to report for admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for admission.
- 7. In case of tie, senior candidate on the basis of Date of Birth shall be given preference. In case of any dispute, the decision of the University administration shall be final.
- **8.** The admission of candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
- 9. The candidates shall be required to pay the fees in the form of Challan at the time of admission.
