4. The skill tests for the post of Private Secretary (*i.e., English Typing Speed and English Stenography Speed*) and Lower Division Clerk (*i.e., English Typing Speed*) is **compulsory**. However, these tests will only be of qualifying nature. **Assessment will not (NOT) be done on the basis of marks of such tests.**
5. For the post of Assistant Registrar and System Analyst the top 5 (five) candidate's who have secured maximum marks in Written Examination will be interviewed before the Selection Committee.
6. Final Selection for the post of Section Officer / Private Secretary / Assistant / Upper Division Clerk / Lower Division Clerk will be on the basis of candidate's performance in the Written Examination and for the rest of positions it will be on the basis of candidate's performance in Interview.
7. For the post of Private Secretary and Lower Division Clerk, the candidates who have secured maximum marks in Written Examination will be called for Skill Test. If the selected candidate is not able to qualify the skill test then the next candidate in order of merit will be called for skill test.

All questions will be of Objective Multiple Choice Type. The questions in all the above components will be of 10+2 level.

## **12. Syllabus for the Written Examination:**

### **A. General Intelligence & Reasoning:**

Analytical aptitude and ability to observe and distinguish patterns will be tested through questions principally of non-verbal type. This component may include questions on analogies, similarities and differences, spatial visualization, spatial orientation, discrimination, observation, relationship concepts, arithmetical reasoning and figural classification, arithmetic number series, non-verbal series, coding and decoding, etc.

### **B. General Knowledge and General Awareness:**

Questions in this component will be aimed at testing the candidate's general awareness of the environment around him. Questions will also be designed to test knowledge of current events and of such matters of every day observations and experience in their scientific aspect as may be expected of any educated person. The test will also include questions relating to India and Bihar especially pertaining to sports, History, Culture, Geography, Economic Scene, General Polity, Indian Constitution and Scientific Research etc. These Questions will be such that they do not require a special study of any discipline.

### **C. Mathematics:**

This paper will include questions on problems relating to Number Systems, Computation of Whole Numbers, Decimals and Fractions and relationship between Numbers, Fundamental arithmetical operations, Percentages, Ratio and Proportion, Averages, Interest, Profit and Loss, Discount, Mensuration, Time and Distance, Ratio and Time, Time and Work, etc.

### **D. English:**

Candidates' ability to understand basic English, his/her basic comprehension would be tested.

### **E. Knowledge of Rules of Government of India & University Act:**

Questions in this component will be aimed at testing the candidate's knowledge and awareness of Rules of Government of India & University Act. The test will include questions relating to Personnel Administration including recruitment, training, promotion, pay scale and service matters; Reservation and Concessions for SC, ST, OBC, PH etc.; CCS (Leave Rules); Right to Information Act 2005; General Financial Rules; Fundamental and Supplementary Rules & University Act etc.

- 13. The Date, Time and Venue of Interview / Written Examination / Skill Test is subject to change, in which event the new Date, Time and Venue will be notified through University Website ([www.mgcub.ac.in](http://www.mgcub.ac.in)) only. Therefore, the candidates are advised to check the University Website regularly.**

**IMPORTANT INFORMATION TO THE CANDIDATES APPEARING IN  
WRITTEN TEST FOR RECRUITMENT TO VARIOUS NON-TEACHING POSITIONS**

*(Ref.: Employment Notice No. 001/2016 dated 22<sup>nd</sup> March, 2016)*

**A. INTRODUCTION:**

1. These instructions contain details pertaining to various aspects of the examination you are going to take and important instructions about the related matters. The assessment of Answer Sheets / OMR Sheets of 'Objective-Multiple Choice Type' will be done by a computerized machine. Hence, you should carefully read the instructions regarding handling of the answer sheet and the method of marking answers.
2. The University will reject at any stage, the candidature of any candidate who does not reach the eligibility criteria (cut-off) prescribed by the University in different papers at different stages of the examination.
3. Please note that since this is a competitive examination, you have to obtain a high rank in the order of merit to secure appointment. You should, therefore, put in your best efforts in the examination.

**B. GENERAL INSTRUCTIONS:**

**1. Timings:**

- i. Examinations will be conducted during the allocated times as mentioned above.
- ii. The examination hall will be open for admission **15 minutes** before the time scheduled for the commencement of the examination. You are to find your allocated seat but do **NOT** turn over the question paper until instructed at the time of commencement of the examination.
- iii. You will not be admitted for the examination after **10 minutes** of the commencement of the examination.

**2. Personal Belongings:**

All your personal belongings (such as cell phones, bags, pouches, ear / headphones, laptops etc.) must be placed at the designated area outside the examination hall. Please do not bring any valuable belongings except the essential materials required for the examinations.

- i. Any unauthorised materials, such as books, paper, documents, pictures and electronic devices with communication (cell phones) and / or storage capabilities such as tablet PC, laptop, smart watch, portable audio / video / gaming devices etc. are not to be brought into the examination hall.
- ii. **Mobiles are not to be brought into the examination hall.** If your Mobile is found then it will be confiscated and your candidature will be cancelled due to violation of norms given here.



- iii. Photography is **NOT** allowed in the examination hall at **ALL** times.
- iv. All materials and/or devices which are found in violation of any examination regulations will be confiscated.
- v. The University will not be responsible for the loss or damage of any belongings in or outside the examination hall.

### 3. **At the Start of the Examination:**

- i. **DO NOT** turn over the question paper placed on your desk until instructed at the time of commencement of the examination.
- ii. Please place your identification documents (**one latest photo bearing identification proof such as Driving Licence, Voter Card, Aadhaar Card, Identity Card issued by University/College, Income Tax Pan Card in original**) at the top right corner of your examination desk for the marking of attendance and verification of identity during the examination.
- iii. Please check that you have the correct question paper and read the instructions printed on your examination question paper carefully.
- iv. Write your name on the OMR Sheet clearly in the space given. You should write only the required details in the space provided on the cover of OMR Sheet. Providing incorrect / illegible details could risk your OMR Sheet being considered void.

### 4. **During Examination:**

- i. You are not allowed to communicate by word of mouth or otherwise with other candidates (this includes the time when answer scripts are being collected).
- ii. Please raise your hand if you wish to communicate with an invigilator.
- iii. Unless granted permission by an invigilator, you are not allowed to leave your seat.
- iv. **Once you have entered the examination hall, you will not be allowed to leave the hall till the end of the test.**
- v. The blank pages in the Question Booklet are to be used only for candidates' rough work. Solutions or any other materials written on these blank pages will not be marked.

### 5. **At the End of the Examination:**

- i. You are **NOT** allowed to leave the examination hall during the collection of the duly filled ONLINE Application Forms / Question Booklets / OMR Sheets. All candidates must remain seated throughout this period for invigilators to properly account for all copy of duly filled ONLINE Application Forms / Question Booklets / OMR Sheets to be collected.
- ii. Do **NOT** continue to write after the examination has ended. You are to **remain seated quietly** while your answer scripts are being collected and counted.
- iii. No papers, used or unused, may be removed from the examination hall.
- iv. You are to stay in the examination hall until the Chief Invigilator has given the permission to leave. Do **NOT** talk until you are outside of the examination hall.
- v. You are responsible to ensure that the necessary documents i.e., copy of duly filled ONLINE Application Forms / Question Booklets / OMR Sheets are submitted at the end of the examination. If you are present for the examination and do not submit said

documents, you will be deemed to have appeared for the examination and failed the examination concerned.

- vi. Once dismissed, you should leave the examination hall quickly and quietly, and remember to take your personal belongings with you.
6. **Candidate must bring his / her copy of duly filled ONLINE Application Form for the concerned Test with recent coloured photo and one identity proof with photo like Driving License, Voter Card, Aadhar Card, Passport etc. at the Examination Centre failing which candidate will not be allowed to enter in the Examination Centre. He / She must occupy only his / her allotted seat as per his / her Application ID in the seating arrangement made for the concerned Test.**
7. Candidates have been **allowed to appear at the Written Test provisionally** and subject to fulfilment of advertised eligibility conditions on the cut-off date. The candidate should ensure that he/she possesses the requisite Qualification and age etc and fulfils all the eligibility conditions for the said post as per advertisement on the cut-off date. In case, at any stage, it is found that candidate does not fulfil the essential eligibility conditions, his/her candidature shall be immediately cancelled without assigning any reason or notice besides taking such other action as deemed appropriate by the University. No claim / compensation shall be admissible in this regard.
8. Candidate shall be allowed to enter the examination centre **before 15 minutes** of the commencement of the concerned written exam to enable frisking by Security Staff and to enable the Invigilator to check the Application Form and get the attendance marked and thumb impression in the attendance sheet and complete other formalities.
9. **No Candidate will be allowed** entry to the Test Hall **after 10 minutes** of the start of the Test.
10. **No Candidate shall be allowed** to leave the Test Hall **till the end** of the Test.
11. At the start of the examination and within first five minutes, candidates are advised to ensure that all pages of your test booklet are properly printed and test booklet is not damaged in any manner. Serial No. of OMR Sheet and test booklet match with each other. In case of any discrepancy the candidate should immediately report the matter to the invigilator for replacement of test booklet. No claim in this regard will be entertained after five minutes of start of examination.
12. There is no provision to provide or permit a 'writer' in the Test.
13. The Candidates shall be checked for any resource materials frequently and at random by the Invigilators and other staff conducting the Test, routinely and also on the slightest doubt.
14. Candidates are not permitted to use Mobile Phone, Calculators or any other electronic/electrical device. Candidates, therefore, **MUST NOT** bring Mobile Phone, Calculators or any other electronic / electrical device inside the Examination premises. Possession of these items, whether in use or not, will be considered as **"use of unfair means"** in the Examination and appropriate action will be taken by the University against such candidates.

15. Success in the examination confers no right for selection unless the University is satisfied after such verification, as may be considered necessary about the candidate, having regard to his / her conduct in service, that he / she is eligible and suitable in all respects for appointment to the post for which the examination is conducted.
16. The scanned photograph of the candidate on his / her duly filled ONLINE Application Form or attendance sheet will be tallied with the candidate appearing in the examination by the Invigilator. In the event of any discrepancy in the identification and verification of the candidate and photographs, the candidate shall not be allowed to appear in the examination and be liable for criminal prosecution.
17. **AFTER THE EXAMINATION IS OVER, THE CANDIDATE WILL HAND OVER THE COPY OF THE DULY FILLED ONLINE APPLICATION FORM ALONGWITH COPIES OF BANK CHALLAN (if fees paid off-line), ALL SELF-CERTIFIED DEGREES / CERTIFICATES / TESTIMONIALS AND QUESTION BOOKLETS & OMR ANSWER SHET OF THE WRITTEN TEST TO INVIGILATOR AT THE EXAMINATION ROOM.**
18. **CANDIDATES SHOULD PROVIDE A CLEAR PHOTOGRAPH SHOWING FRONT FACE ALONGWITH DOCUMENTS. ANY HAZY, UNCLEAR PHOTOGRAPH SHALL DISQUALIFY CANDIDATES FROM THE ENTIRE SELECTION PROCESS.**
19. No candidate would be permitted to leave the Examination Hall without prior permission of the Invigilator for any purpose whatsoever. Before going to the toilet, the candidate must close his / her Question Booklet / OMR Sheet and not carry any examination material to the toilet. No candidate would be allowed to go to the toilet during the first 30 minutes and last 30 minutes of Examination.
20. Discipline and silence must be observed in the Examination Hall for smooth conduct of the Examination. Smoking, chewing tobacco/masala or taking tea etc. in the Examination Hall is strictly prohibited. Loaning or Interchanging of erasers or any other article of stationary by the candidate is not permitted in the Examination Hall.
21. No candidate will be allowed to leave the OMR sheet fully blank, though one may leave a few blank spots so as to avoid negative marking. If any OMR sheet is found fully blank. It shall be crossed by the invigilator with his/her signature and mentioning "Cancelled.' on it.
22. **The Test of a candidate shall be cancelled in case of any of the following actions by a candidate:**

Relevant or irrelevant resource material or loose paper found on his / her possession, or, lying on or around his / her seat, Possession of any unauthorized instrument or equipment as mentioned at (vi) above / document / paper/ information materials or any resource materials, Communication of information in writing or verbally or exchange of Question Booklet / Answer Sheets to and from any other person during the Test period and any other malpractice amounting to obtaining undue advantage, Any alterations or corrections in the entries made by a candidate in Question Booklet and OMR Sheet [Application ID in words & figures and OMR sheet No. in Question Booklet and Application ID, Question Booklet No. and Set No. (if any) in OMR sheet] but not duly verified by the invigilator concerned, Non-matching of signature made at the time of Test with that already done at the time of filling of Application Form.

**23. The Test of a candidate shall be cancelled in case of any of the following actions by a candidate:**

Tampering with the photograph, Face not resembling the photograph in the Application Form, Not occupying the allotted seat, Tampering / disturbing the seating arrangements, Smuggling-out or smuggling-in Question Booklet in part or in full, or Test material, or any resource material connected with the Test, Making any attempt to influence the University Authorities directly or indirectly, misbehaving with invigilation staff, disturbing or trying to disturb the Test, noting down the questions or their answers, Shouting of slogans or creating unruly scene at the Examination Hall / Examination Centre.

**24. Suppression / concealment of information:** The candidate must ensure that he / she is qualified to appear in the Test. If it is detected at any stage that he / she did not fulfil the minimum qualifications, or, there was something against the candidate or, the candidate has provided false information or no information about his/her previous involvement in an act punishable under law or act of gross misconduct and indiscipline, then his / her candidature shall not be considered.

**25.** Nobody other than the University authorized personnel is permitted to move around the Test venue. Any unauthorized person loitering around the Test venue shall be handed over to the police under an FIR lodged by the University.

**26. No scrutiny / re-evaluation of answer sheet of TEST is allowed in any case at any stage.**

**27.** Any request for change of date of test(s) / interview / seat in the Examination Hall will not be entertained. The University reserves the right of cancelling the candidature of any candidate found indulging in any malpractice i.e. hiding any material information, misrepresentation of facts or canvassing for candidature. All such candidates are liable to be debarred from this examination as well as future examinations, in addition to appropriate legal action as may be decided by the university.

**28.** Candidates have been **allowed to appear at the Written Test provisionally** subject to the final verification of Mark sheets / Degrees / Certificates, validity of Certificates / Mark sheets, etc. at the time of Interview / Skill Test / Joining. The candidates are required to bring original documents at the time of Written Test / Joining.

Mere appearance in the Written Test or qualifying in the Test does not entitle a candidate to be considered for appearing at the interview unless he / she fulfil the eligibility conditions. **APPLICANTS MUST FULLY SATISFY THEMSELVES ABOUT THEIR ELIGIBILITY AS PRESCRIBED IN THE ASDVERTISEMENT, BEFORE APPEARING IN THE TEST.** If an applicant is inadvertently allowed to appear at the Test / Interview who otherwise does not fulfil the minimum eligibility requirements, he/she cannot, at a later date, use that as a right to claim that he / she meets the eligibility requirements. The University reserves the right not to allow a candidate to appear at Interview / Join the University, or even terminate services if it is found that:

- a. Minimum eligibility requirements are not fulfilled despite of clearing Written Test.
- b. False documentation has been done.
- c. Any other similar valid reason.

29. The appointment of the candidate who have secure more marks in Written Examinations is **provisional** and is subject to qualifying of skill test, if any; verification of his / her Character & Antecedents; and if applicable his / her Caste / Tribe / Community Certificate from the respective authorities through proper channel. If the verification reveals anything adverse about your character and antecedents and / or that the claim to belong to the Scheduled Caste / Scheduled Tribe / Other Backward Class or not belonging to creamy layer, as the case may be, is false, his / her services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates.
30. Candidates are warned not to fold or make any stray marks on the OMR Answer Sheet. Use of Eraser, Nail, Blade, White Fluid / Whitener etc. to smudge, scratch or damage in any manner on the OMR Sheet during Examination is strictly prohibited. Candidature / OMR Sheet of candidates using Eraser, Blade, Nail or White Fluid / Whitener to smudge, scratch or damage in any manner the Answer Sheets shall be cancelled.
31. The Written Examination will be supervised by doing frisking before allowing entry into Examination Centre, using CCTV Cameras and Photograph of the candidates during Examination, Videography and using Jammers etc. in the Examination Hall / Examination Centre to stop copying and impersonation etc.
32. If a candidate does not comply with the instructions as mentioned above or creates any kind of indiscipline, the University shall take action as per instructions and in addition can also debar the candidate from appearing in the Examination, to be held in future by Mahatma Gandhi Central University and can also file criminal proceedings.

**33. ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:**

Candidates are warned that they should not furnish any particulars that are false or suppress any material information in filling up the application form. Candidates are also warned that they should in no case correct or alter or otherwise tamper with any entry in a document or its attested / certified copy submitted by them nor should they submit a tampered / fabricated document. If there is any inaccuracy or any discrepancy between two or more such documents or their attested/certified copies, an explanation regarding this discrepancy should be submitted.

A candidate who is or has been declared by the University to be guilty of:

- a. Obtaining support of his/her candidature by any means; or
- b. Impersonating; or
- c. Procuring impersonation by any person;
- d. Submitting fabricated documents or documents which have been tampered with; or
- e. Making statements which are incorrect or false or suppressing material information; or
- f. Resorting to any other irregular or improper means in connection with his/her candidature for the selection; or
- g. Using unfair means during the test; or
- h. Writing irrelevant matter including obscene language or pornographic matter, in the script(s); or

- i. Misbehaving in any other manner in the examination hall; or
- j. Harassing or doing bodily harm to the staff employed by the University for the conduct of their test; or
- k. Bringing mobile Phone/communication device in the Examination Hall / Interview Room; or
- l. Attempting to commit or, as the case may be, abetting the University of all or any of the acts specified in the foregoing clauses may, in addition to rendering himself/herself liable to criminal prosecution, be liable:
  - i. to be disqualified by the University from selection for which he/she is a candidate; and/or
  - ii. to be debarred either permanently or for a specified period by the:
    - University from any Examination or Selection held by them.
    - University from taking admission under the courses offered by them.
  - iii. if he/she is already in service under Government to disciplinary action under the appropriate rules.

#### **34. RESOLUTION OF TIE CASES:**

- a. The tie is resolved by the University by referring to the total marks in the Written Examination i.e. a candidate having more marks in the written examination gets preference over the candidate(s) with less marks.
- b. If the tie still persists then the marks in Knowledge of Rules of Government of India & University Act and English (*for the post of Assistant Registrar, System Analyst, Section Officer, Private Secretary, Assistant, UDC and LDC*) are referred to i.e., a candidate having more marks in the concerned subject will be given preference.
- c. If the tie still persists, the candidate having more marks in English will be given preference.
- d. If the tie still persists, the candidate older in age gets preference.
- e. If the tie still persists, it is finally resolved by referring to the alphabetical order of names i.e. a candidate whose name begins with the alphabet which comes first in the alphabetical order gets preference.

#### **35. UNIVERSITY DECISION FINAL:**

The decision of the University in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, conduct of examination(s), allotment of examination centres and preparation of merit list will be final and binding on the candidates and no enquiry/correspondence will be entertained in this regard.

#### **36. COURTS' JURISDICTION:**

In case of any disputes, any suites or legal proceedings against the University in regard to this recruitment, the territorial jurisdiction shall be restricted to the Courts in Bihar at District Court at Motihari and High Court at Patna.

## METHOD OF ANSWERING IN THE TEST

1. A Question Booklet containing the questions, a separate Answer Sheet / OMR Sheet and **Ball Point Pen for marking the answers shall be provided to the candidate at the beginning of the Test.**
2. The candidate, within 10 minutes of the issue of the Question Booklet, shall check the Question Booklet to ensure that it contains all the pages in correct sequence and that no page / question is missing. In case of faulty Question Booklet, the candidate shall immediately bring it to the notice of the Superintendent / Invigilators to obtain a fresh Question Booklet.
3. The candidate is required to write his / her Application ID and Set No., if any, at the appropriate places provided in the Answer Sheet / OMR Sheet in INK / Ball Point Pen (**provided by the University**) only. In addition, he / she is also required to fill up Application ID in the space provided on the Answer Sheet / OMR Sheet by darkening the appropriate ovals by Ball Point pen (**provided by the University**) only.

**NOTE:** Please note that any error in darkening the Application ID or writing set number will result in wrong evaluation of the Answer Sheet / OMR Sheet. He / She may take further note that non-filling of Set No., if any, Roll No. and other vital details would lead to non-evaluation of Answer Sheet / OMR Sheet and cancellation of his / her candidature. Hence, the candidate should be careful in darkening Application ID and writing set number.

4. The candidate is required to write in INK / Ball Point Pen (**provided by the University**) only, his / her Application ID and Serial Number of Answer Sheet / OMR Sheet at the appropriate places on the cover page of the Question Booklet.
5. Each question shall be followed by four alternative answers. The candidate is required to identify the one which he / she feels to be the correct answer and record the answer by darkening the appropriate oval in the Answer Sheet / OMR Sheet with Ball Point Pen (**provided by the University**) only.

For example, if out of 4 alternatives (1) (2) (3) & (4) given against question No. 15, the candidate identifies (2) as the correct answer, he / she is required to darken the oval No. 2 only in the Answer Sheet as given below:

6. The answer will be treated incorrect if more than one oval is darkened or an oval is darkened improperly. Any other method of marking such as tick mark, cross mark, use of dot, line mark and half-filled oval or marks outside the oval shall not be evaluated.
7. **NEGATIVE MARKING: There will be negative marks for wrong answers in the objective tests. One half (i.e., 0.50 marks) marks will be deducted for each wrong answers.**
8. If any question is not attempted, the candidate is required to leave all the ovals against that question as blank. Such an answer will be awarded *zero* mark.
9. Inner cover page of the Question Booklet or the blank space / page at the end of Question Booklet may be used for rough work.

10. No page from the Question Booklet is to be torn or removed. If a candidate is found tearing any page from the Question Booklet, he / she shall be liable to punishment for adopting unfair means and shall not be allowed to continue in the Test.
