## Item No: (2016) AC: 01:01To report to the Academic Council, the matter regarding<br/>establishment of Mahatma Gandhi Central University, Motihari<br/>(District - East Champaran), Bihar.

The Mahatma Gandhi Central University is established by an Act of Parliament [under Central Universities (Amendment) Act 2014 (No. 35 of 2014)] of Indian Parliament, which received the assent of the President on the 17<sup>th</sup> December 2014.

The territorial jurisdiction of the University is North of River Ganges in the State of Bihar (Motihari in East Champaran). Since the place was the "KARAMBHOOMI" of the father of the nation, where he successfully experimented with the idea of "SATYAGRAH" during the "NEEL ANDOLAN" at Champaran in 1917, therefore, the University is named as "MAHATMA GANDHI CENTRAL UNIVERSITY".

A copy of the Central Universities (Amendment) Act 2014, as notified in the Official Gazette is annexed herewith **(ANNEXURE - 1.1)**.

#### Item No: AC (2016):01:02

#### To report to the Academic Council, the appointment of Prof. (Dr) Arvind Kumar Agrawal as First & Founder Vice-Chancellor of the University.

His Excellency, the President of India in his capacity as the Visitor of the Mahatma Gandhi Central University, appointed Prof. (Dr) Arvind Kumar Agrawal as First & Founder Vice-Chancellor of the Mahatma Gandhi Central University for a term of five years as conveyed by MHRD vide their letter No.F.51-1/2015-Desk U dated 20<sup>th</sup> January 2016.

Consequent upon relieving from Central University of Himachal Pradesh, Dharamshala, Prof. (Dr) Arvind Kumar Agrawal assumed the charge of the office of the First & Founder Vice-Chancellor of the Mahatma Gandhi Central University, Bihar with effect from 3<sup>rd</sup> February 2016 (Afternoon) and the University became functional w.e.f. 3<sup>rd</sup> February 2016 (Afternoon) with its headquarters at Motihari (District – East Champaran).

A copy of letter No. 51-1/2015-Desk U dated 10<sup>th</sup> February 2016 of Deputy Secretary to the Government of India, MHRD, New Delhi addressed to Secretary, UGC regarding Joining of Prof. (Dr) Arvind Kumar Agrawal as First Vice-Chancellor of Mahatma Gandhi Central University, Bihar is annexed herewith **(ANNEXURE – 1.2)**.

## Item No: AC(2016):01:05 To report to the Academic Council, the matter regarding Launch of University Website (www.mgcub.ac.in).

The University became functional w.e.f. 3<sup>rd</sup> February 2016 with the assumption of charge by Prof. (Dr.) Arvind Kumar Agrawal as First & Founder Vice-Chancellor of the University. Since the University is in nascent stage and the University has to recruit various non-teaching and teaching positions on deputation/regular/short-term contract basis, it was felt necessary that the University should have its own website to make it possible to provide instantly viewable information and even downloadable content about the University. Accordingly, the University has awarded the contract to INFLIBNET Centre, Gandhinagar for preparing its website. The domain name has been registered at *ac.in* domain with the Ernet. A copy of the proposal to the effect submitted by INFLIBNET is annexed herewith **(ANNEXURE – 1.5)**.

Information and Library Network (INFLIBNET) Centre, Gandhinagar is an Autonomous Inter-University Centre (IUC) of University Grants Commission (UGC) of India.

The Website of the University **(www.mgcub.ac.in)** was launched by the then Hon'ble Minister of Human Resource Development Smt. Smriti Zubin Irani on 21<sup>st</sup> March, 2016 in her chamber at MHRD, New Delhi.

#### Item No: AC(2016):01:06 To report to the Academic Council, the progress in transfer of land by the State Government of Bihar to Mahatma Gandhi Central University for its establishment.

The process of transfer of permanent land of 301.75 Acres near Bankat-Bairiya Village (near Government Motihari Engineering College) duly approved by the Site Selection Committee constituted by the Central Government, by the State Government of Bihar is in hand.

The latest position on transfer of said land to University as informed by the District Land Acquisition Officer, Motihari, District – East Champaran vide its letter No.370/GB dated 24<sup>th</sup> August 2016 is annexed herewith **(ANNEXURE – 1.6)** for kind information of the Academic Council.

# Item No: AC(2016):01:07To report to the Academic Council, the matter regarding General<br/>Cultural and Scientific Co-operation Agreement ('MoU') signed<br/>between Sapienza University of Rome (Italy) and Mahatma<br/>Gandhi Central University, Motihari (Bihar).

The University is going to start programmes of studies in various disciplines and in order to provide best opportunities to its students, it is in negotiations with premier higher educational and research institutions and government and state level bodies/authorities/ boards to enter into MoUs.

Accordingly, the University in consultation with Sapienza University of Rome (Italy) has signed General Cultural and Scientific Co-operation Agreement ('MoU'). A copy of signed agreement is annexed herewith **(ANNEXURE – 1.7)**.

#### A brief about the Sapienza University of Rome (Italy) is as under:

The Sapienza University of Rome, officially Sapienza – Università di Roma, also called simply Sapienza or the "University of Rome", is a collegiate research University located in Rome, Italy. Formerly known as Università de glistudi di Roma "La Sapienza", it is the largest European University by enrolments (the third if considering also the distance learning schools) andone of the oldest in history, founded in 1303.

La Sapienza educated numerous notable alumni, including many Nobel laureates, presidents of the European Parliament, heads of several nations, notable religious figures, scientists and astronauts.

**Academics:** Since the 2011 reform, Sapienza University of Rome has eleven faculties and 65 departments. Today Sapienza, with 1, 40,000 students and 8,000 among academic and technical and administrative staff, is the largest University in Italy. The university has significant research programmes in the fields of engineering, natural sciences, biomedical sciences and humanities. It offers 10 Masters Programmes taught entirely in English.

**Ranking:** As claimed by the Academic Ranking of World Universities (Arwu), Sapienza is regularly ranked first among Southern European universities. Sapienza is positioned within the 101-150 group of universities and among the top 3% of universities in the world.

In 2015, the Centre for World University Rankings ranked the Sapienza University of Rome as the 112th in the world and the top in Italy in its *World University Rankings*.

The Academic Council noted the Item and appreciated the efforts of the Vice-Chancellor being taken for the growth of students and staffs of the University.

Item No: AC(2016):01:08To report to the Academic Council about the action taken by the<br/>Vice-Chancellor under sub-section (3) of Section 11 of the<br/>Central Universities Act 2009 with regard to approval of<br/>University Prospectus 2016-17 for admission to various Under-<br/>Graduate and Post-Graduate Programmes.

The University became functional w.e.f. 3<sup>rd</sup> February 2016 with the assumption of charge by Prof. (Dr.) Arvind Kumar Agrawal as its First Vice-Chancellor. Consequent upon the request of the University, the University Grants Commission vide their letter No.F.83-1/2015 (CU) dated 17<sup>th</sup> February 2016 has granted approval for opening of 20 teaching departments with teaching strength in the ratio of 1:2:4 (One Professor, Two Associate Professors and Four Assistant Professors for each department) with 140 teaching positions (20 Professors, 40 Associate Professors and 80 Assistant Professors).

As per Statute 14(d), the power to frame such regulations and rules consistent with the Statutes and the Ordinances regarding the academic functioning of the University, discipline, residence, admission, award of fellowship and studentships, fees, concessions, corporate life and attendance is vested with the Academic Council of the University. As such, the Prospectus of the University for the Academic Year 2016-17 for admission to Certificate, Under-Graduate and Post-Graduate Programmes was required to be considered and approved by the Academic Council.

Since the process of making admissions could not be started until the prospectus is approved by the competent authorities i.e. Academic Council and the meeting of University Authorities i.e., Academic Council / Executive Council could not be convened for want of their constitution by the Central Government, therefore taking a holistic view that the admission process is an important and time bound activity, the Prospectus 2016-17 of the University was approved by the Vice-Chancellor, in exercise of the powers vested in him vide sub-section (3) of Section 11 of the Central Universities Act 2009, in anticipation of the approval of the Academic Council and the admission process is in hand. A copy of the Prospectus issued by the University contains all details viz. Name of Department, Number of Seats in each Department, Fees, admission etc., is annexed herewith **(ANNEXURE – 1.8)**.

The Academic Council noted the Item and congratulated & appreciated the Vice-Chancellor for bringing out the First Prospectus of the University is such a short span of time.

## Item No: AC(2016): 01:09To report to the Academic Council about the creation of various<br/>teaching positions and latest position of ongoing teachers'<br/>recruitment process of the University.

Consequent upon the request of the University, the University Grants Commission vide their letter No.F.83-1/2015 (CU) dated 17<sup>th</sup> February, 2016 has granted approval for opening of 20 teaching departments with teaching strength in the ratio of 1:2:4 (One Professor, Two Associate Professors and Four Assistant Professors for each department) with 140 teaching positions (20 Professors, 40 Associate Professors and 80 Assistant Professors).

Since, the University was proposing to start its First Academic Session from September, 2016 itself and the First Academic Council / First Executive Council were not constituted by the Central Government, therefore, the Vice-Chancellor by exercising the powers vested in him under sub-section (3) of Section 11 of the Central Universities Act 2009, in anticipation of the approval of the Academic Council, has approved to open total 15 teaching departments out of 20 sanctioned teaching departments and accordingly, alongwith 105 teaching positions (One Professor, Two Associate Professors and Four Assistant Professors for each Department) as per details given below:

#### Latest position of ongoing teachers' recruitment process of the University:

- 1. The University vide Employment Notice No. 003/2016 dated 5<sup>th</sup> July 2016 advertised 105 teaching positions (15 Professor, 30 Associate Professor and 60 Assistant Professor).
- 2. Subsequently, the University vide its addendum to the advertisement dated 5<sup>th</sup> July 2016 on 19<sup>th</sup> July 2016 informed all the concerned candidates that a Written Screening Test containing 100 Multiple Choice Questions carrying 100 marks lasting for duration of 90 minutes would be held for the position of Assistant Professor in fifteen programmes on 13/08/2016 at Nalanda University, Patna.
- 3. The test was compulsory but of qualifying nature. After conducting the screening test for all the 15 (Fifteen) programmes on 13<sup>th</sup> August 2016 in three slots at the earmarked Examination Centre at Patna, the result was declared and uploaded on the University Website on 17<sup>th</sup> August 2016.
- 4. Top 5 (Five) candidates per post were shortlisted for Interview in order of merit in the screening test.
- 5. The University incorporated in its recruitment process the University Grants Commission 4<sup>th</sup> Amendment regarding 'Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education' notified vide UGC notification dated 11<sup>th</sup> July 2016.
- 6. A Screening Committee constituted by the Vice-Chancellor, Mahatma Gandhi Central University scrutinized the applications for the posts Assistant Professor, Associate Professor and Professor of the candidates to see whether they were eligible or not on the basis of 4<sup>th</sup> Amendment of UGC.
- 7. The Committee also scrutinized applications in accordance with the latest UGC regulations and prepared a list of 'Eligible' and 'Not Eligible' candidates.
- 8. Further course of action is in progress.
- 9. The details of no. of candidates applied, no. of candidates found eligible/not eligible for the post of Professor in various disciplines are also given below for kind perusal of the Academic Council:

The Principal, Zila School, Motihari (Bihar) handed over the 'Old DIET' Building to the University vide their letter No. 187 dated 29<sup>th</sup> June 2016.

The old building was dilapidated condition and urgently needed repair & renovation to make it worthy of starting academic activities. The repair & renovation of the said building is being go done by the Central Public Works Department.

The Academic Council noted the Item. After their visit to site, all the members of the Academic Council unanimously applauded the quality of work and the pace with which it is being carried out, keeping in view the challenge to start the First Academic Session of the University from October 2016 itself.

#### Item No: AC(2016):01:13 To report to the Academic Council about the International Seminar being organised by Mahatma Gandhi Central University on 'Past, Present and Future of Indology: Challenges & Prospects' on 8-9 September, 2016.

In order to provide platform for the convergence of intellectuals and to embark on churning on the certain themes, the University proposes to organize an International Seminar on 'Past, Present and Future of Indology: Challenges & Prospects' on 8-9 September 2016. Since utmost care is being taken to ensure that the Ordinances are framed in consonance with the best practices found anywhere in the world, the process is taking a longer time.

## Item No: AC(2016):01:18To report to the Academic Council, the competition organised by<br/>the University for finalisation of the University Logo.

In order to develop and design the Logo of the Mahatma Gandhi Central University, the University launched a nationwide competition for anyone aged over 18 years of age interested in Art and Design.

A reward of **Rs.40,000/-** (Rupees Forty Thousand only) in cash and a Certificate has been allotted for the winning entries.

Invitation for participation along with a detailed terms and conditions for participation in the Competition was sent via E-mail to various Institutions and Individuals.

The detailed terms and conditions of Logo Design Competition of Mahatma Gandhi Central University is annexed herewith **(ANNEXURE – 1.18)**.

The Committee for selecting and finalizing the Logo of the University is yet to be constituted for owing to multiplicity of activities going on to kick start the first academic session of the University.

The recommendations of the said Committee will be placed before the University Authorities in due course of time.

The Academic Council appreciated the Vice-Chancellor for this competition and authorised him to take further necessary decision(s) in this regard.

## Item No: AC(2016):01:19To place before the Academic Council, the proposal regarding<br/>constitution of Curriculum Development Committees and Ad-hoc<br/>Board of Studies.

Subject to the overall control and supervision of the Academic Council, normally the functions of the Board of Studies shall be:

- i. To approve subject for research for various degree and the other requirements of research degree.
- ii. To recommend to the concerned School Board:
  - a. Courses of studies and appointment of examiners but excluding research degree.
  - b. Appointment of supervisors for research.
  - c. Measures for the improvement of the standard of teaching and research.
- iii. To ensure that the curricula and syllabi of various courses offered by the teachers in the Departments are periodically reviewed and continuously revised and updated.

The First Academic Session of the University is likely to commence within a couples of weeks and keeping in view the fact that the University is in its nascent stage and the process of Teachers' Recruitment is underway. Therefore, the constitution of regular Board of Studies and School Boards thereof may take some time, therefore, it is proposed to constitute Ad-hoc

Boards of Studies for those programmes of studies that are planned to be commenced from the forthcoming Academic Session.

The Academic Council considered the proposal and authorised the Vice-Chancellor to constitute the required Curriculum Development Committee and ad-hoc Board of Studies and also to take all other necessary action in the matter.

#### Item No: AC(2016):01:20 To place before the Academic Council, the Curriculum for the Programmes of Study launched as approved by UGC for the time being with the provision for subsequent revision after duly constituted Board of Studies and School Board is in place.

The University Grants Commission has approved Curriculum for several Under Graduate Programmes on 10<sup>th</sup> April 2015. Among such programmes, the University has proposed to introduce following programmes.

- ix) Bachelor of Science (Physics Honours)
- x) Bachelor of Science (Chemistry Honours)
- xi) Bachelor of Science (Maths Honours)

Since, Sociology is not among the programmes for which the UGC has approved Curriculum, therefore, the Curriculum adopted by the Delhi University in June 2015 has been taken for consideration.

Master of Social Work, UGC Curriculum which became effective from 2015-16 has been taken for consideration.

Further, Curriculum for Master of Business Administration adopted by Delhi University form 2014-15, has been taken for consideration.

The University has received a large number of applications and the process of screening all the applications received for the positions of Professor, Associate Professor and Assistant Professor in accordance with the UGC Regulations have already been completed.

The University is proposing to hold Selection Committees for the various teaching positions shortly. The Clause 5.1.1, 5.1.2 and 5.1.3 of "UGC Regulation on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010", inter alia, provides that the Selection Committee for the posts of Assistant Professors, Associate Professors and Professors shall have "Three experts in the concerned subject nominated by the Vice-Chancellor out of the panel of names approved by the relevant statutory body of the University concerned".

The Academic Council considered the proposal and authorised the Vice-Chancellor to nominate any working / retired Professor of Central / State Universities or Institutions of National Importance to act as experts in the Selection Committee for the post of Professor, Librarian, Associate Professor, Deputy Librarian, Assistant Professor and Assistant Librarian.

Item No: AC(2016):01:22 To place before the Academic Council, the proposal for transferring one post of Associate Professor to Deputy Librarian and one post of Assistant Professor to Assistant Librarian to facilitate the establishment & functioning of Library, till the UGC sanctions regular post of Deputy Librarian and Assistant Librarian.

> Library is an integral part of University Education System. However, the University Grants Commission has granted approval to open 20 departments in the University with teaching position of Professor, Associate and Assistant Professor in the ratio of 1:2:4. There is no position of Librarian.

> The proposal to transfer one post of Associate Professor to Deputy Librarian and one post of Assistant Professor to Assistant Librarian to facilitate the establishment & functioning of Library has been sent to the University Grants Commission.

#### The Academic Council considered and recommended the same to the Executive Council for approval.

At the end, the members of the Academic Council expressed their satisfaction on the progress made in the establishment of the University so far. In particular, the Academic Council put on record its appreciations and commendations for the Vice Chancellor and his small team for an excellent Strategic Plan and meticulous execution for the University in such a short span of time.
