The process of Admission for various UG and PG Programme of Studies in five new teaching departments for the upcoming Academic Session 2019-20 is in hand.

For smooth conduct of ongoing admission process various amendments in the existing Ordinance No. 1 are proposed. Accordingly, revised (*after carrying out necessary amendments/changes/modification*) Ordinance No. 1 of the University dealing with Admission of Students to the University is attached at ANNEXURE – 15.01 (i).
