This is to inform all the applicants of Ph.D. Computer Science program for the Academic Session 2020-21 that a Viva-Voce cum-counselling and admission process **is scheduled on 11th December 2020.** Note that it is a mandatory component of evaluation process meant for admission. Admission will be made on the basis of the composite score of the Entrance Test and Interview/Viva-voce. It will be calculated by giving 70% weightage to the Entrance Test and 30% weightage to the Interview/Viva-Voce in accordance to the provisions made in the Ph.D. Ordinance No 35. of the University. Candidates having UGC-CSIR NET/JRF/SLET/GATE will be given weightage inside the Viva-Voce component as decided by the Departmental Research Committee (DRC). All the eligible candidates (enclosed with this pdf) must report to the venue at the scheduled time and date.

INSTRUCTIONS:

- 1. Candidates are advised to follow the COVID-19 guidelines at the time of counselling.
- 2. Students have to bring the research proposal at the time of viva-voce.
- 3. All candidate must bring their academic documents in original and a set of self-attested photocopy. Candidates under reserved category (SC/ST/OBC/PWD/EWS) have to bring relevant category certificate as per GOI norms.
- 4. Admission fee of Rs. 23218 /- will be submitted through Demand Draft only, which shall be drawn in favour of "Mahatma Gandhi Central University" payable at Motihari.
- 5. Admission shall be strictly based on the merit list, which will be based on the composite score.
- 6. All candidates are advised to check their eligibility for respective programmes as notified by MGCUB admission prospectus 2020-21 before appearing for counselling / admission.
- 7. Admission against seats falling vacant later due to one or another reasons, shall be announced later on university website.

- 8. Merely obtaining the cut off marks or bringing Demand Draft does not guarantee the admission.
- 9. Candidates who fail to report for admission along with all the original documents on scheduled date and time shall forfeit their claim to be considered for admission.
- 10. In case of same marks obtained in the merit list, then the senior candidate on basis of Date of Birth shall be given preference. In case of any further dispute the decision of the DRC shall be final.
- 11. The admission of candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
- 12. Admission shall be granted only on payment of fees on the specified date for each program.
- 13. Candidates who fail to make payment on the date of admission shall not be considered for admission and the seat will be given to the next candidate in the merit list.
- 14. In case of any dispute related to the provisional admission, the High Court of Patna shall have the jurisdiction.
- 15. In case of delay in admission/counselling process candidates have to make their own arrangement of stay.
- 16. Any addendum/corrigendum/notices to this notification shall be published only on the University Website (www.mgcub.ac.in). Therefore, Candidates are advised to check the website regularly for any updates.
