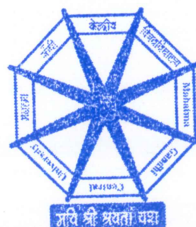
Subject: Live Broadcast of Pariksha Pe Charcha 2022 on 1st April 2022 (Friday) – Reg.
