OFFICE ORDER

- In compliance of the provisions contained under UGC (Credit Framework for Online Learning Courses through Study Webs of Active Learning for Young Aspiring Minds) Regulations, 2021 & further consequent upon the recommendations of the Committee constituted for implementations of the said Regulations, the Competent Authority has been pleased to order the following: -
 - (i) All the Teaching Departments/Schools of the university will create provision for up to 40% of their credit to be earned through SWAYAM portal through duly approved by the respectively Board of Studies (BOS). The same is to be reflected in the respective curriculum also.
 - (ii) All the Deans /Heads/In-Charges shall ensure to:-
 - (a) Identify the SYAYAM based online credit courses with due approval of their respective Board of Studies;
 - **(b)** Notify the same within four weeks from the date of notification of the SWAYAM based online credit course under sub- regulations (5). The list of SWAYAM based online credit course for the ensuing semester shall be notified on the SWAYAM platform before the $01^{\rm st}$ November for the January Semester and before the $01^{\rm st}$ June for the July Semester, every year.
 - **(c)** Designate a faculty member as a facilitator to guide the students form registration till completion of the credit course.
 - (iii) Students will submit their final marks/grades obtained after final evaluation form their host institution to their respective Head of the Departments.
 - (iv) Controller of Examinations (CoE) will chalk out its operational part for transferring the credit and its reflections in the Markssheets. However, Dean of the respective School will forward the credits earned and approval of the respective Board of Studies to the Controller of Examinations (CoE) after obtaining the same from the Head of the Departments.
