- 1. The Candidates who have valid CUET (PG) – 2022 score and have also filled the Registration form and paid the registration fee of Mahatma Gandhi Central University, Bihar.**
- 2. The Candidates who have valid CUET (PG) – 2022 score and have filled the Registration form but not paid the registration fee* of Mahatma Gandhi Central University, Bihar.**
- 3. The Candidates who have valid CUET (PG) – 2022 score but have not filled the Registration form* of Mahatma Gandhi Central University, Bihar.**

Important Instruction

1. Candidates are advised to follow the COVID guidelines at the time of counselling.
2. Admission shall be based on CUET (PG) - 2022 score.
3. Candidates are advised to report on the scheduled date and time to the venue along with required documents.
4. All candidates are advised to check their eligibility for respective programmes as notified by NTA Information Bulletin for the admission in PG programme through CUET (PG) – 2022.

5. Candidates who fail to report for admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for admission.
6. In case of tie, senior candidate on the basis of Date of Birth shall be given preference. In case of any dispute, the decision of the University administration shall be final.
7. The admission of candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
8. The candidates shall be required to pay the fees in the form of **Challan** at the time of admission.
9. Admission shall be granted only on the payment of fees on the specified date.
10. Candidates who fail to make payment on the date of admission shall not be considered for admission and the seat will be given to the next candidate in the merit list.
11. In case of any dispute related to the provisional admission, the High Court of Patna shall have jurisdiction.
12. Any addendum/corrigendum/notices to this notification shall be published only on the University Website (www.mgcub.ac.in). Therefore, Candidates are advised to check the University website regularly for any updates.

The candidates are required to be present in person and bring the following documents in **original** as well as a set of **attested photocopies** at the time of reporting for admission:

1. CUET (PG) – 2022 application form.
2. NTA score card of CUET (PG) – 2022 score.
3. CUET (PG) – 2022 registration form if registered.
4. Marksheets and certificates of 10th and 12th.
5. Marksheet and Certificate of Graduation.
6. Five copies of recent passport size photographs.
7. Self-attested copy of AADHAR card.
8. Bank Account detail of student i.e. Account No., IFSC-Code, Name of account holder & address of Bank.
9. A Character certificate from the Head of the Institution last attended.
10. Transfer/Migration Certificate (in original) from the Head of the Institution/University last attended.
11. Affidavit for intervening period/gap of over three years, if applicable on 10/- stamp paper.
12. Valid SC/ST/OBC-NCL/PwD/EWS Certificate as per GOI rules, wherever applicable.
13. No Objection Certificate (NOC) from Employers, wherever applicable.
14. Anti-ragging forms duly signed by the students & parents/guardians. (Format attached at **Annexure-I and Annexure-II** in the University Prospectus).
