- 2. Admission will be made strictly on the basis of CUET(PG)-2023 score obtained by the candidates. The candidates, who have valid CUET(PG)-2023 score, filled the Registration form and paid the registration fee of Mahatma Gandhi Central University, are eligible to take part in the Counseling cum- Admission Process.
- 3. List of Candidates called for Counseling-Cum-Admission in M.A. Public Administration Programme is attached herewith the Notice.
- 4. The structure and other details are mentioned in the admission notifications (Postgraduate Programmes, Academic session: 2023-24) available at University website.

Important Instructions

- 1. Admission shall be based on CUET (PG) 2023 score.
- 2. Candidates are advised to report on the scheduled date and time to the venue along with the required documents.
- 3. Candidates who fail to report for admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for admission.
- **4.** In case of a tie, the senior candidate on the basis of Date of Birth shall be given preference. In case of any dispute, the decision of the University administration shall be final.
- 5. The admission of a candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
- **6.** The candidates shall be required to pay the fees in the form of **Challan** at the time of admission.
- 7. Admission shall be granted only on the payment of fees on the specified date.
- **8.** Candidates who fail to make payment on the date of admission shall not be considered for admissionand the seat will be given to the next candidate in the merit list.
- 9. In case of any dispute related to the provisional admission, the High Court of Patna shall have jurisdiction.
