2. Then, the Candidates who have valid CUET (PG) – 2023 score and **have filled the Registration form but not paid the registration fee*** of Mahatma Gandhi Central University, Bihar.
3. Then, the Candidates who have valid CUET (PG) – 2023 scores but **have not filled out the Registration form*** of Mahatma Gandhi Central University, Bihar.
4. If the seat remains vacant, the option will be given to the Candidates **who have not given the CUET (PG) – 2023 exam*,#** in the open counselling.

* The candidates interested in taking admission have to pay registration fees (Rs. 500/- for Gen/OBC/EWS and Rs. 200/- for SC/ST/PWD) through DD/challan along with the admission fee (Rs. 15718/-)

The candidate who has not appeared in CUET (PG) – 2023 examination will be admitted based on a composite score, which will be determined as follows:
