**On Spot Admission will be done in the following order of preferences:**

1. Candidates who have a valid CUET (PG)-2024 (COQP08) score for M.Com, and have filled the Registration form and paid the registration fee earlier at Mahatma Gandhi Central University will be given **1<sup>st</sup> preference**.
2. Candidates who have a valid CUET (PG)-2024 (COQP08) score for M.Com, but have not filled the registration form of Mahatma Gandhi Central University will be given **2<sup>nd</sup> preference\***.
3. If the seats still remain vacant, the candidates who have not given the CUET (PG)-2024 exams will be given **3<sup>rd</sup> preference\*** and admission will be made on the basis of composite score.

The composite score will be determined as follows:-

5. The candidates shall be required to pay the fees in the form of **Challan** at the time of admission.
6. Admission shall be granted only on the payment of fees on the specified date.
7. Candidates who fail to make payment on the date of admission shall not be considered for admission and the seat will be given to the next candidate in the merit list.
8. In case of any dispute related to the provisional admission, the High Court of Patna shall have jurisdiction.
