### **GENERAL INSTRUCTIONS**

- 1. Candidates are advised to report on the scheduled date and time at the venue along with required documents.
- 2. All candidates are advised to check their eligibility for respective programmes as notified by NTA Information Bulletin for the admission in PG programme through CUET (PG)– 2024.
- 3. Candidates who fail to report for admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for admission.
- 4. In case of tie, the marks obtained in the merit list shall be the deciding factor and if, that is also the same or the result of both candidates is not declared then the senior candidate on the basis of Date of Birth shall be given preference. In case of any dispute, the decision of the University administration shall be final.
- 5. The admission of a candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
- 6. The candidates shall be required to pay the fees through Challan at the time of admission.
- 7. Admission shall be granted only on payment of fees on the specified date for each program.
- 8. Candidates who fail to make payment on the date of admission shall not be considered for admission and the seat will be given to the next candidate in the merit list.
- 9. In case of any dispute related to the provisional admission, the High Court of Patna shall have jurisdiction.
- 10. Any addendum/corrigendum/notices to this notification shall be published only on the University Website (www.mgcub.ac.in). Therefore, Candidates are advised to check the website regularly for any updates.
