- BA (Hons./Pass) Degree in English or Bachelor's degree of 3 years duration with English as a subject from a recognised Indian or foreign university (foreign recognition to be as per AIU list).
- Candidates with a Bachelor's Degree in any discipline under 10+2+3 education pattern with adequate proficiency in English.
- Minimum 50% marks or equivalent grade for Unreserved category and 45% marks or equivalent grade for SC/ST/OBC (NCL)/PwD/EWS candidates.

IMPORTANT INSTRUCTIONS

1. Candidates who are interested in appearing for Open Counselling and have not paid the registration fees to MGCU will be required to pay registration fees (INR 500/- for General/OBC/EWS category, INR 200/- for SC/ST/PWD category) on the date of Open Counselling through Bank Challan/ Demand Draft.
2. Candidates are advised to report to the venue on the scheduled date and time, along with the required documents. **Candidates who fail to report for admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for admission.**
3. In case of a tie, a senior candidate based on Date of Birth shall be given preference. The University administration's decision shall be final in case of any dispute.
4. The admission of a candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
5. The candidates shall be required to pay the fees as a **Challan/ Demand Draft** drawn in favour of "**Mahatma Gandhi Central University,**" payable in **Motihari** at the time of admission.
6. Admission shall be granted only upon payment of fees on the specified date.
7. Candidates who fail to make payment on the date of admission shall not be considered for admission, and the seat will be given to the next candidate on the merit list.
8. If, at a later stage, any information is found to be incorrect, the admission is liable to be cancelled.

4. Marks sheet and Certificate of Graduation.
5. Five copies of recent passport-size photographs.
6. Self-attested copy of AADHAR card.
7. Bank Account details of the student, i.e. Account No., IFSC-Code, Name of account holder & address of Bank.
8. A Character certificate from the Head of the Institution last attended.
9. Transfer/Migration Certificate (in original) from the Head of the Institution/University last attended.
10. Affidavit for intervening period/gap of over three years, if applicable on 10/- stamp paper.
11. SC/ST/OBC/PwD/EWS Certificate as per GOI rules, wherever applicable.
12. No Objection Certificate (NOC) from Employers, wherever applicable.
13. Anti-ragging forms duly signed by the students & parents/guardians. (The format is attached in Annexure-I and Annexure-II in the University Prospectus. The same is attached in this Counselling-cum-Admission notice).
