## **Instructions for Candidates**

1. Admission shall be strictly based on CUET (UG) Score-2024.
2. Candidates are advised to report on the scheduled date and time to the venue along with required documents.
3. All candidates are advised to check their eligibility for respective programme as notified by NTA Information Bulletin for the admission in UG programme through CUET (UG) – 2024 before appearing for counselling / admission.
4. Merit-listed candidates who fail to appear at the scheduled date and time will forfeit their eligibility for future counselling rounds.
5. Candidates who fail to report for admission along with all the original documents on the scheduled date and time shall lose their claim to be considered for admission.
6. In case of a tie, senior candidate on the basis of Date of Birth shall be given preference. In case of any dispute, the decision of the University administration shall be final.
7. The admission of candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
8. The candidates shall be required to pay the fees in the form of a **Demand Draft (DD) in favour of “Mahatma Gandhi Central University” payable at Motihari, drawn on any nationalized bank**, at the time of admission.
9. Admission shall be granted only on the payment of fees on the specified date.
10. Candidates who fail to make payment on the date of admission shall not be considered for admission and the seat will be given to the next candidate in the merit list.
11. In case of any dispute related to the provisional admission, the High Court of Patna shall have jurisdiction.
12. Any addendum/corrigendum to this notification shall be published only on the University Website ([www.mgcub.ac.in](http://www.mgcub.ac.in)). Therefore, Candidates are advised to check the University website regularly for any updates.

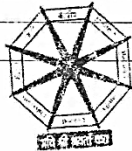

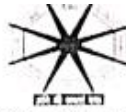



**Revised Guidelines and Fee Structure for the Supernumerary Self Finance/ Paid Seats**

**(Applicable from Academic Session 2024-25)**

- (i) The seats under the Self-Finance Scheme will be 20 percent (20%) of the existing total sanctioned seats in each teaching department. Seats under the Self-Finance Scheme shall be offered for such Programme(s) of Study/Course(s) which are financially viable, to be decided by the Competent Authority from time to time.
- (ii) Seats under the Self-Finance Scheme may be increased or decreased as per the feasibility and viability of the Programme of Study/Course, on the recommendation of the concerned Teaching Department with the prior approval of the Competent Authority.
- (iii) The admissions on the Self-Financed Seats shall be available for the students who have applied for admissions against the advertisement issued by the University, strictly on the basis of merit as per CUET (UG/PG) score. The Departments may interact with interested candidates before admission.
- (iv) Any additional resources generated by such super-numerary seats may be made available partially to the concerned Department for academic resources and infrastructure. This matter shall be placed before university statutory authorities for further consideration and approval.
- (v) Any student admitted under this (Self-Financed) Scheme shall not be allowed to switch to regular seats under any circumstances, barring fresh admission through CUET.
- (vi) The students, to be admitted under the Self-Financed Scheme, shall have to deposit/pay a Lumpsum Course Fee *(as per detail given below)* in addition to Regular Fees paid by the students *admitted under the Non-Self-Financed category*:

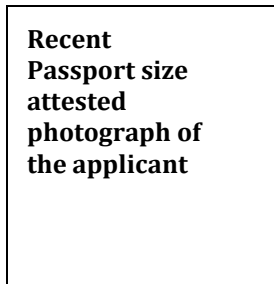
