**Notice for Interview/Viva-Voce-cum Admission to Ph.D. Programme 2024-25 in the
Department of Computer Science and IT**

Candidates seeking admission to the Ph.D. programme of the Department of Computer Science and IT are required to attend the offline Interview/Viva-Voce Examination. The names of candidates eligible for the Interview/Viva-Voce Examination are in the annexed lists. Candidates are required to report as per the following details

The provisional Merit List for Admission will be displayed on 30th/31st January 2025 on the University Website/Campus Notice Board based on the Composite Merit Score after the Interview/Viva-Voce. Students are requested to visit the University website regularly. Reservation is applicable as per existing rules and norms applicable at MGCU.

Note:

- Provisional admission shall be strictly based on the merit list derived from the composite score of marks of relevant examination and marks of interview in accordance with the provisions of the University Ordinance.
- Candidates are required to report personally on the scheduled date and time to the venue along with required documents.
- Candidates are required to come with Research Proposal (5 hard copy) and PPT (Max 10 slides of ppt) to be presented before the Department Research Committee (DRC) during the interview.
- All candidates are advised to check their eligibility for respective programmes as notified by MGCU admission prospectus 2024-25 (<https://mgcub.ac.in/pdf/202411031241151e452aad30.pdf>) before appearing for Interview-cum-Admission.
- Merely obtaining the cut-off marks does not guarantee admission. The department reserves the right to fill or not to fill any or all seats. The decision will be taken on the basis of suitability of the candidate vis-à-vis readiness of supervisor in proposed research area as well as availability of resources.**



- Candidates who fail to report personally for provisional admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for provisional admission.
- Candidates who fail to make the payment by due date shall not be considered for provisional admission and the seat will be given to the next candidate in the merit list/waiting list (if any).
- In case of any dispute related to the provisional admission, the High Court of Patna shall have the jurisdiction.
- Any addendum/corrigendum/notices to this notification shall be published only on the University website (www.mgcub.ac.in). Therefore, candidates are advised to check the University website regularly for any updates.
- No TA/DA will be paid to the candidates for appearing in Interview for admission to the above programme.
- Students are requested to come with all the documents required for admission in the course. Unable to present the required documents will lead to cancellation of the admission.
- The scheduled Interview for provisional admission is likely to be continued till late evening or next- day depending upon the circumstances. Therefore, the candidates are advised to make their own arrangement for stay etc. accordingly.
- Provisional admission shall be granted only on the payment of fees by due date.
- The candidates shall be required to Deposit of Fees through Samarth Portal (online) From 30/01/2025 (Thursday) to 31/01/2025 (Friday). No fee will be refunded in case of Withdrawal/Cancellation of admission after 15th February 2025.**

- Five copies of recent passport size photographs.
- Self-attested copy of AADHAR card.
- Original Extra- /Co-Curricular Activities Certificates, if any.
- Bank Account detail of student i.e. Account No., IFSC-Code, and Name of account holder & address of Bank.
- A Character Certificate from the Head of the Institution last attended.
- Transfer/Migration Certificate (in original) from the Head of the Institution /University last attended.
- Affidavit for intervening period/gap of over three years, if applicable on 100/- stamp paper.
- SC/ST/OBC(NCL)-latest/PwD/EWS-latest Certificate as per GoI rules, wherever applicable.
- No Objection Certificate (NOC) from Employers, wherever applicable.
- Anti-ragging forms duly signed by the students & parents/guardians. (Format attached at **Annexure- I and Annexure-II** in the University e-Prospectus).
