# NOTICE FOR OPEN COUNSELING-CUM-ADMISSION OF M.Sc. ZOOLOGY SCHOOL OF LIFE SCIENCE, ADMISSION (2025-26)

- 1. This has a reference to the office order (*F. No. MGCUB/CoE/CUET-2025/PG/1804*; *Dated:25<sup>th</sup> July, 2025*) regarding an **Open Counselling** for admission through Samarth portal against **vacant seats** in M.Sc. Zoology programme in the **Department of Zoology, MGCU, Motihari Bihar.**
- 2. The candidates interested in taking admission in the M.Sc. Zoology for the academic session 2025-26 are directed to register themselves on the MGCUB/Samarth Portal by paying a non-refundable registration fee of Rs. 500 /- for General/OBC/EWS and Rs. 200 for SC/ST/PWD from 25 July to 3<sup>rd</sup> August, 2025.
- 3. The link for registration/open admission is: mgcubadm.samarth.edu.in

#### **Criteria for Open Counselling**

- i. Open counselling will be initiated by the department against the vacant seats for the following category of candidates:
  - CUET score card holders (first preference)
  - Without CUET score card holders (but fulfilling eligibility criteria of MGCUB)
- **ii.** During open counselling, the admission shall be made on the merit of CUET score. Once such candidates are exhausted, merit will be prepared based on the composite score, to be determined on the basis of the score obtained in 10<sup>th</sup>, 12<sup>th</sup>, and Graduation as per following details:

### **Important Instruction**

- 1. Admission shall be based on CUET (PG) 2025 score.
- 2. All candidates are advised to check their eligibility for respective programmes as notified by NTA Information Bulletin for the admission in PG programme through CUET (PG) 2025.
- 3. In case of tie, senior candidate on the basis of Date of Birth shall be given preference. In case of any dispute, the decision of the University administration shall be final.
- 4. The admission of candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
- 5. Admission shall be granted only on the payment of fees on the specified date.
- 6. Candidates who fail to make payment on the date of admission shall not be considered for admission and the seat will be given to the next candidate in the merit list.
- 7. In case of any dispute related to the provisional admission, the High Court of Patna shall have jurisdiction.
- 8. Any addendum/corrigendum/notices to this notification shall be published only on the University Website (www.mgcub.ac.in). Therefore, Candidates are advised to check the University website regularly for any updates.
