1. Provisional admission shall be strictly based on merit list derived from the composite score of NET/JRF Score and Marks of Interview/Viva-voce in accordance to the provisions made in the University Ordinance.
2. Candidates are required to **report personally** on the scheduled date and time to the venue along **with required documents**.

- 3. Candidates are required to make presentation on a **Research Proposal** before Department Research Committee (DRC) during the interview. They are requested to send the Research Proposal (PDF format) to the following email id- **headcommerce@mgcub.ac.in** on or before **8th February, 2026** by 05:00 PM.**
- 4. All candidates are advised to check their **eligibility** for the PhD Commerce programme as notified by MGCU admission prospectus 2025-26 (<https://mgcub.ac.in>) before appearing for Interview / Viva-Voce Examination.**
- 5. Merely obtaining the cut-off percentile does not guarantee for admission.**
- 6. Candidates who fail to report personally for provisional admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for provisional admission.**
- 7. The provisional admission of a candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.**
- 8. The candidates shall be required to pay the fees through Samarth portal after final provisional result declaration.**
- 9. Provisional admission shall be granted only on the payment of fees by due date.**
- 10. Candidates who fail to make the payment by due date shall not be considered for provisional admission and the seat will be given to the next candidate in the merit list/waiting list (if any).**
- 11. In case of any dispute related to the provisional admission, the District Court at Motihari shall have jurisdiction.**
- 12. Any addendum/corrigendum/notices to this notification shall be published only on the University website (<https://mgcub.ac.in>). Therefore, **candidates are advised to check the University website regularly for any updates.****

GENERAL GUIDELINES REGARDING PROCESS OF ADMISSION IN MAHATMA GANDHI CENTRAL UNIVERSITY

Students from all over India and the world, as per the policies of the Government of India, are welcome to seek admission in Mahatma Gandhi Central University. Reservation and relaxations in admission is provided to the students as per the policies of the Government of India. The general guidelines regarding the process of admission in various Ph.D. Programmes of the University are given below:

ADMISSION/ELIGIBILITY CRITERIA

- The admission in PhD programme in Mahatma Gandhi Central University (MGCU) for Academic Year 2025-26 will be made in terms of the UGC Public Notice No.F.4-1 (*UGC-NET Review Committee*)/2024(NET)/140648, dated March 27, 2024. Accordingly, based on the scores obtained in UGC-NET, the candidates will be eligible in three categories.
 - ❖ **Category - 1:** Eligible for (i) admission to Ph.D. with JRF and (ii) appointment as Assistant Professor.
 - ❖ **Category - 2:** Eligible for (i) admission to Ph.D. without JRF and (ii) appointment as Assistant Professor.
 - ❖ **Category - 3:** Eligible for admission to Ph.D. programme only and not for the award of JRF or appointment as Assistant Professor.
- Those students who are having valid JRF prior to 2025, as per UGC Guidelines, in relevant subject are eligible to apply for Ph.D. Programmes offered by respective Department.
- For admission under Category 2 and 3, qualifying in UGC-NET/UGC-CSIR/December-2024/June-2025 cycle and similar National Level Tests/GATE/GPAT as per their validity shall be the eligibility criteria for applying
- Those students who have cleared only NET prior to December 2024 are not eligible to apply for any of the Ph.D. programmes.
- As per UGC (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2022, relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the UGC from time to time.
- The candidates applying for admission in Ph.D. Programme must fulfil the eligibility criteria on or before the last date of applying.



APPLICATION/REGISTRATION FEE

The application fee for admission to various Ph.D. programme of studies for different categories of applicants are as under:

❖ General/OBC/EWS	:	Rs. 500/-
❖ SC/ST/PwBD	:	Rs. 200/-

Note:

- i. An applicant can apply for payment through net-banking/debit/credit card/UPI.
- ii. GST and other taxes as applicable by Govt. of India/Bank.
- iii. A candidate who desires to apply for more than One Programmes of Studies shall be required to pay prescribed application fee separately for each Programme/Course.
- iv. Applicants are advised to read Payment instructions carefully before paying the application fee.
- v. Application fee once paid shall not be refunded in any case. Candidates shall be required to make the payment of application fee through SMARTH portal in online mode while filling up application form.

SELECTION PROCESS

➤ For admission to all Ph.D. Programmes under all Categories (viz. Category 1, 2 & 3), **70% weightage will be given for valid test scores and 30% weightage for the interview.**

The Ph.D. admission will be based on the combined merit of valid NET marks and the marks obtained in the Interview.

➤ Interview shall be conducted only of those eligible candidates who have submitted the online application form and shortlisted for interview. The interview will be conducted in the respective Departments of the MGCU.

➤ Department-wise schedule and procedure of interview for admission in Ph.D. Programme shall be notified in due course on University Website (www.mgcub.ac.in).

EDUCATIONAL QUALIFICATION

The following are eligible to seek admission to the Ph.D. programme:

(1) Candidates who have completed:

- i. A 1-year/2-semester master's degree programme after a 4-year/8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-year bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the
