- 1. Candidates are advised to follow the COVID guidelines at the time of counselling.
- 2. Admission shall be strictly based on merit list, which will be prepared based on the score of students who have reported on 26<sup>th</sup> October 2021 at 11:00 AM sharp along with required documents.
- 3. The merit list will be displayed on the notice board on 27 October 2021. After that
- 4. Admissions will be processed between 27<sup>th</sup> October 2021 to 30<sup>th</sup> October 2021 and if the vacant seat, then admission will be processed from the waiting list against the vacant seats.
- 5. All candidates are advised to check their eligibility for respective programs as notified by MGCUB admission 21 before appearing for counselling/admission.
- 6. Admission against vacant seats falling vacant at a later date due to one or another reasons, shall be announced
- 7. Merely obtaining the cut off percentile or bringing Demand Draft does not guarantee admission.
- 8. Wait-listed candidates shall only be considered for admission if seats remain vacant in given program of studies.
- 9. Candidates who fail to report for admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for admission.
- 10. In case of a tie, the marks obtained in the merit list shall be the deciding factor and if, that is both candidate is not declared then the senior candidate on basis of Date of Birth shall be given preference. In case of any dispute, the decision of the University administration shall be final.
- 11. The admission of candidate who has passed his/her qualifying examination from a Foreign University will be being found equivalent to the qualifications prescribed by the University.
