5. If at any stage it is found that the applicant has furnished wrong information in the online application form then the admission would be cancelled.
6. **Admission** into B.Com.(H) programme **would be confirmed only after** document verification and submission of proof of fee deposit through challan.

# Admission of candidates seeking admission after a gap of three or more academic years of passing Intermediate/10+2 examination from any University/educational institution/Board, shall be subject to the clearance by the **Admission Review Committee** consisting of the Dean, Students' Welfare (DSW), the Dean of the School concerned, the Head of the Department concerned and the Proctor.
