- 1. At the time of counseling / admission candidates must use face covers/masks within University premises.

- 3. From the pool of candidates who **report within due time on the day of counseling**, admission would be done in order of merit for all the categories, subject to reservation rules and overall intake capacity of **33 seats** in M.Com.
- 4. **Fee** payable at the time of admission into the M.Com. programme is **Rs. 9,218/-.** The fee would be deposited on the day of admission after document verification through challan. - 5. If at any stage it is found that the applicant has furnished wrong information in the online application form then the admission would be cancelled.
- 6. **Admission** into M.Com. programme **would be confirmed only after** document verification and submission of proof of fee deposit through challan.

Admission of candidates seeking admission after a gap of three or more academic years of passing Intermediate/10+2 examination from any University/educational institution/Board, shall be subject to the clearance by the **Admission Review Committee** consisting of the Dean, Students' Welfare (DSW), the Dean of the School concerned, the Head of the Department concerned and the Proctor.
